

Bequests

What is a bequest?

A bequest is an instruction in your will to leave a gift (money, property or other asset) to a specific person, organisation or charity. We recommend that you seek legal advice when writing your will, and that you should discuss the instructions you are making in your will with your relatives or loved ones.

Changing a will?

Thankfully, making or revising a will is neither difficult nor expensive. It is essential that you have a will. Surprisingly, many do not. If you have already made your will, you or your solicitor can easily add the Anglican Parish of the Parks as a beneficiary through a short legal amendment to your existing will (also known as a codicil).

Types of Bequests

There are three types of bequests:

- A set amount of money
 (also known as a "pecuniary" bequest)
- 2. A residue or a %age of the residue of your estate once other bequests have been made (also known as a "residuary" bequest)
- 3. A specific asset e.g. property, artworks or shares (also known as a "specific" bequest)

For many donors, the residuary bequest is the most popular.

Suggested Wording

The Anglican Church of Australia is governed by the Church of England in Australia Constitution Act, 1960 and the Anglican Church of Australia Constitution (Amendment) Act, 1977. It is a national voluntary religious association as described in "Scandrett v Dowling".
